Notice on behalf of non-applicant/petitioners has been accepted by Mr. Amit Jhanji, Advocate and notice on behalf of respondent-State has been accepted by Mr. Harish Rathee, Sr. D.A.G., Haryana.

Having no objection from either of the side, the Civil Misc. Application is allowed and Sainpal Sidhu Cooperative Transport Society Limited, Sainpal, District Sirsa through its President is hereby impleaded as respondent No.8.

CWP No.4206 of 2015

This order shall dispose of **CWP Nos.4206 of 2015** and **10371 of 2015** as the issue involved in both the cases is similar.

Learned counsel for the petitioners has relied upon letter dated 07.05.2015, issued by Transport Commissioner, Haryana, Chandigarh, circulated to all Secretaries, Regional Transport Authorities in the State of Haryana, whereby, it has been mentioned that the matter regarding issue of time table with regard to the stage carriage permits granted under the Stage Carriage Schemes has been considered by the State Government and it has been decided that the stage carriage permits issued under Stage Carriage Scheme, 2013 and permits holders of 1993 and 2001 Schemes are also eligible for obtaining permits under the Stage Carriage Scheme of 2013 as mentioned in para No.3 of the notification dated 12.08.2013 and those permits be treated as valid as per the terms and conditions of the respective permits. It has also been directed that permits be issued accordingly in view of those directions.

Learned counsel for the respondent-State submits that the directions have already been issued vide aforesaid letter and the case of the petitioners will be considered.

Accordingly, in view of the submissions made by learned

counsel for the parties, respondents No.2 to 7 are directed to consider the claim of the petitioners in view of directions issued on 07.05.2015 and in case, the petitioners are found to be eligible, necessary permit be issued to them within a period of one month from the date of receipt of certified copy of this order.

The petition is disposed of accordingly.
