This is an application under Order 1 Rule 10 read with Section 151 CPC for impleading the applicant-Gram Panchayat, Bilaspur, Tehsil Manesar, District Gurgaon as respondent No.5.

Heard.

Learned counsel for the non-respondents/petitioners states that he has no objection if the present application is allowed.

In view of above, instant application is allowed. Applicant-

CWP-4750-2015

Instant petition has been filed under Articles 226/227 of the Constitution of India for quashing the letter dated 09.03.2015 (Annexure P-10) issued by respondent No.3-Deputy Commissioner, Gurgaon whereby separation of Gram Panchayat, Bilaspur into two parts i.e. Gram Panchayat, Bilaspur Kalan and Gram Panchayat, Bilaspur Khurd, has been recommended.

It is the case of the petitioners that entire proceedings have been initiated at the instance of an individual. Although some of the residents of village have moved application that there should be no separation of Gram Sabha, but the impugned letter has been issued for separation of Gram Sabha into two Gram Panchayats.

In pursuance of notice of motion, respondent Nos.1 to 4 have filed reply with the averments that Bilaspur Kalan has been notified as separate Gram Panchayat vide Haryana Govt. Gaz. (Extra) dated 08.04.2015 (Annexure R-3/1).

At this stage, learned counsel for the petitioners wants to
