This order shall dispose of aforementioned four Letters Patent Appeals i.e. LPA Nos. 444-445 of 2010 and 478-479 of 2011, whereby the appellants have challenged the order dated 18.02.2010 passed by learned Single Judge of this Court wherein the reservation of plots for Members of Parliament and of Legislative Assembly, were set aside. The writ petitioners are the societies consisting of Members of Parliament and of Legislative Assembly, former and present.

Mr. Mahajan, learned Advocate General, Haryana, states that no allotment has been made to any Members of Parliament and of Legislative Assembly under the Group Housing Scheme, 2005 and the policy for allotment of plots to the Members of Parliament and of Legislative Assembly by

The same are disposed of as infructuous.

However, It shall be open for the writ petitioners to impugn the decision of the State Government before an appropriate authority/Court in accordance with law.
