1. Whether Reporters of local papers may be allowed to see the judgment?
2. To be referred to the Reporters or not?

AJAY TEWARI, J. (Oral)

The grievance raised in this writ petition is that similarly situated persons are getting personal pay allowance but the same has not been granted to the petitioners. Learned counsel has argued that in this connection the petitioners are stated to have got issued a legal notice dated 15.12.2014(Annexure P-6) which has not been decided as yet. Learned counsel states that at this stage the petitioners would be satisfied if a direction is issued to respondent No.2 to decide the said legal notice in accordance with law by passing a speaking order thereon.

I find this to be a fair request.

Resultantly this petition is disposed of with a direction to respondent No.2 to decide the legal notice(Annexure P-6) of the petitioners

within a period of two months from the date of receipt of a certified copy of this order in accordance with law by passing a speaking order thereon and in case the petitioners are found entitled to the relief claimed, grant them the same within another period of one month thereafter. Since the dispute in this case relates to monetary benefits, it is made clear that in case any due payment is not made within the aforesaid time, the petitioners would be entitled to claim the same with interest at the rate of 8% p.a. from the date/s the payment/s fell due.

Since the main case has been decided, the Civil Misc. Application, if any, also stands disposed of.
