Counsel for the petitioner has referred to a communication dated 24.03.2011 (Annexure P-2) received by the petitioner-Cooperative Society, wherein the part of the work, which has been executed by the petitioner has been admitted. Thereafter the petitioner has been approaching the respondents for release of the amount due to the petitioner for the work of construction of internal roads in the campus of Rajiv Gandhi Thermal Power Project, Khedar, District Hisar but the same has not been released till date.

Counsel contends that the petitioner, at this stage, would be satisfied if a direction is issued to the Managing Director, Haryana State Road and Bridges Development Corporation Limited, Deputy General Manager, Haryana State Road and Bridges Development Corporation Limited and Executive Engineer, Haryana State Road and Bridges Development Corporation Limited-respondents No.2 to 4 respectively, to consider the claim of the petitioner, as has been submitted by it in its

representation dated 01.09.2014 (Annexure P-6), which is addressed to Executive Engineer-Haryana State Road and Bridges Development Corporation Limited, Provincial Division No.3, PWD B&R Branch, Hisar, District Hisar-respondent No.4 and copies thereof were forwarded to respondents 2 and 3 respectively.

In view of the statement made by the counsel for the petitioner, without going into the merits of the case or commenting thereon, the present writ petition is disposed of with directions to Managing Director, Haryana State Road and Bridges Development Corporation Limited, Bays No.13-14, Sector-2, Panchkula, District Panchkula, Deputy General Manager, Haryana State Road and Bridges Development Corporation Limited, Jind, District Jind and Executive Engineer, Haryana State Road and Bridges Development Corporation Limited, Provincial Division No.3, PWD B&R Branch, Hisar, District Hisar-respondents No.2 to 4 respectively to consider and decide the representation dated 01.09.2014 (Annexure P-6) submitted by the petitioner, within a period of two months from the date of receipt of certified copy of this order.

In case the claim of the petitioner is accepted, the consequential benefits, if any, be released to it, in accordance with law, within a further period of six weeks. In case the claim of the petitioner is not to be accepted, a well reasoned and speaking order be passed and conveyed to the petitioner forthwith.
