Main Case

The appellant challenges judgment and decree dated 09.04.2015 passed by the Additional District Judge, Jalandhar, passing a decree of divorce.

The parties namely; Ekta (wife) and Sourabh (husband) are present in the Court with their respective counsel.

Ekta, the appellant, and Sourabh, the respondent, state that they have decided to resume matrimony and live together as husband and wife. The parties pray that their statements may be recorded.

Let the statements of parties be recorded.

The statements made by the parties in the Court today, have been duly signed by parties and witnessed by their respective counsel. The statements read as under:-

“Statement of Sourabh son of Shri Harbhajan Lal, at present posted as Assistant Controller of Defence Accounts, Him Parisar, AO, R&D, Sector 37-A, Chandigarh. (On S.A.)

Stated that my marriage was solemnized with Ekta (appellant) on 25.10.2013 at Arya Samaj Mandir, near Majnu Ka Tilla Gurudwara at Delhi. On account of difference, I had filed a petition for divorce in the Court against Ekta, which was allowed. Ekta has instituted various petitions, suits, complaints, FIRs, both in civil, criminal and administrative side. I have no objection if the appeal is allowed and judgment and decree dated 09.04.2015, passed by the Additional District Judge, Jalandhar, dissolving our marriage, is set aside.

Appellant Ekta may be directed to withdraw her complaints/FIRs, suits and departmental complaints which have been filed against me or my family members.

I undertake to resume the matrimonial relationship.
