Satish Kumar Mittal, J. (Oral):

This order shall dispose of aforementioned 13 appeals as these are directed against the common judgment dated 14.11.2014 passed by the learned Single Judge whereby the writ petitions filed by the respondents herein were allowed and the instructions dated 28.02.2013 issued by the Government of Haryana providing 20% reservation in promotion in Class-III and IV posts to Scheduled Castes employees was set aside.

Today, learned counsel for the State has placed on record a fresh instructions dated 15.05.2015, whereby the earlier instructions dated 28.02.2013 to the extent of providing for reservation in promotion to Class III and Class IV posts for Scheduled Castes category employees has been withdrawn and the new policy on the basis of the report submitted by P. Raghvendra Rao Committee has been formulated providing 20% reservation in promotion with consequential seniority to the Scheduled Castes category employees in Class-III and IV posts.

In view of the above, the present appeals have become infructuous.

Ordered accordingly.
