Dr. Bharat Bhushan Parsoon, J. (Oral):

Counsel for the petitioner seeks transfer of the petition under Section 13 of the Hindu Marriage Act, 1955 (in short the Act) filed by the respondent-husband for dissolution of marriage by decree of divorce from Ludhiana to Patiala, where she is residing with her four year girl child, claiming that continuance of petition under Section 13 of the Act at Ludhiana would cause great hardship to her as she would not be able to contest the same competently, effectively and wholesomely with a small child to take care of. It is averred that the respondent-husband is already contesting petition under Section 125 Cr.P.C. at Patiala but this petition under Section 13 of the Act has been preferred by him at Ludhiana merely to harass and humiliate her.

No notice is being issued to the respondent in order to obviate delay, more so when no prejudice is likely to be caused to the respondent in

view of the nature of order which this Court proposes to pass.

In view of the circumstances explained in the petition and particularly when the husband is already contesting proceedings under Section 125 Cr.P.C. at Patiala, the petition under Section 9 of the Hindu Marriage Act, 1955 is ordered to be transferred from Ludhiana to the court of competent jurisdiction at Patiala. Compliance be made by the District & Sessions Judge, Ludhiana.

The petition stands disposed of.
