5	Date & time of inspection of the suit property by the prospective buyers. (The DH would make the necessary arrangements in this regard in consultation with the owner of the suit property).	24 th August to 4 th September, 2017 between 10.00 am to 1.00 pm.
6	Public auction of the suit property	14 th September, 2017
