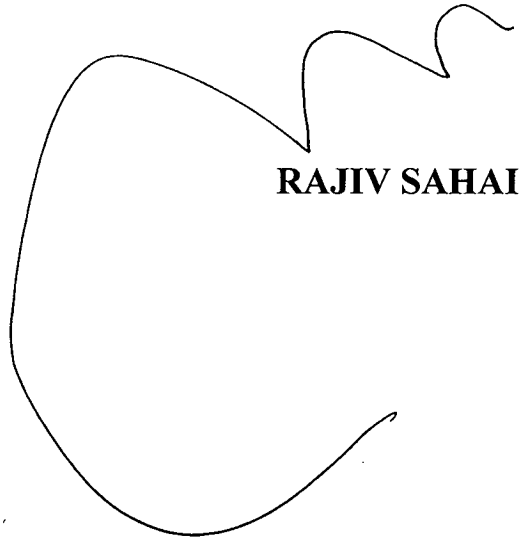
5. The counsels for the respondents have no objection.
