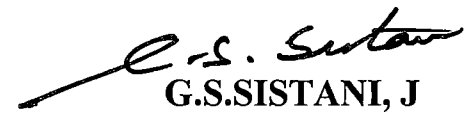
CRL.L.P. 468/2014, CRL. A. 1224/2013 & CRL. A 1620/2013

State seeks leave to appeal in respect of a judgment passed by the trial court on 18.05.2013.
