We have heard the counsel for the parties.

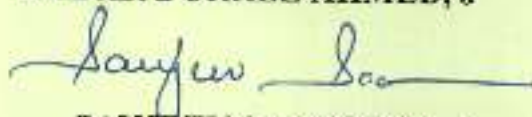
