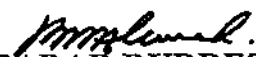

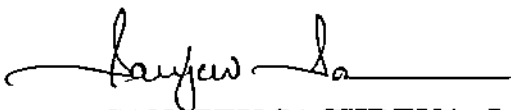

We dispose of these petitions with a direction that the Land Acquisition Collector shall forward the reference petitions to the Reference Court within a period of six weeks from today in accordance with law.
