Jai Prakash University, Chapra is mandated to provide affiliation, otherwise the recognition or permission, which has been granted by National Council of Teachers Education for the academic session 2015-2016 for intake of 50 students, will prove to be illusory.

Since the university's authorities have not taken a decision, the writ application has been filed.

Counsel for the petitioner informs the Court that the team constituted by the university for carrying out the inspection has already done so on 06.02.2015.

Obviously, it is a case of apathy on the part of the university's authorities not to take a final decision or call on the issue.

Writ application is disposed off with a direction that the decision with regard to affiliation must be taken within a period of three weeks from today.

Writ application stands disposed off with observation / direction as above.
