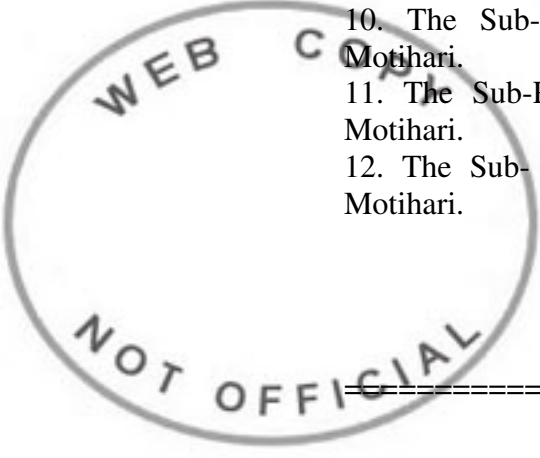

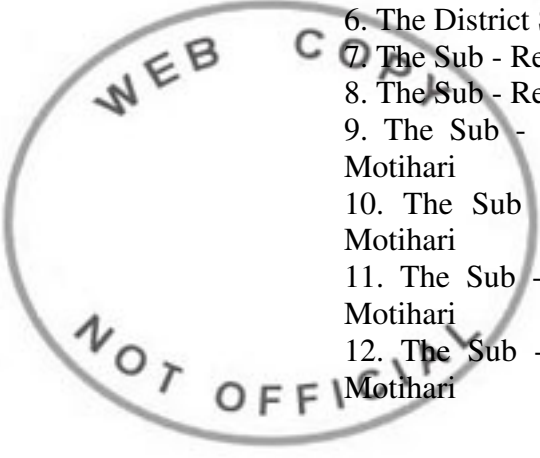

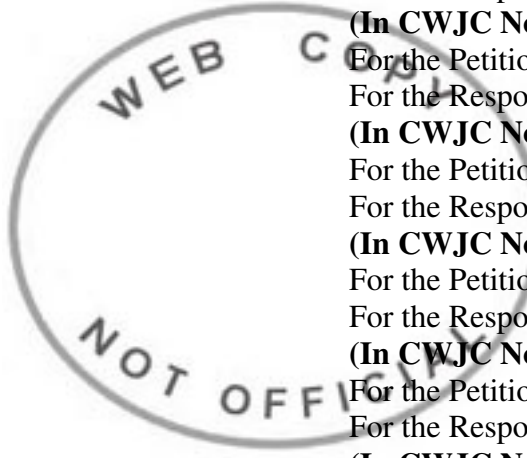

Learned counsel for the parties are present and are heard with a view to final disposal.

The petitioners in these batch of writ petitions are Licensed Deed Writers and who are aggrieved by the advisory issued by the Principal Secretary, Department of Registration, Excise and Prohibition bearing Memo No. 2867 dated 13.6.2016 whereby a

direction has been issued to all District Sub Registrars as well as District Registrar only to accept such deeds which are computer typed.

The parties are in agreement that the issue raised in these batch of writ petitions, is squarely covered by the judgment and order of this Court passed in **C.W.J.C.No.10973 of 2006 (Arbind Kumar Vs. State of Bihar)** and analogous cases. This Court in consideration of the rival contentions in the case referred to above has upheld the contention raised by the petitioners to quash the advisory issued by the Principal Secretary dated 13.6.2016.

In view of the judgment and order passed in **C.W.J.C.No.10973 of 2016 (Arbind Kumar Vs. State of Bihar)** and analogous cases, all these writ petitions are allowed and since the order bearing No. 2867 dated 13.6.2016 passed by the Principal Secretary, Department of Registration, Excise and Prohibition already stands quashed, no further order needs to be passed in that regard.

The writ petitions are accordingly allowed.
