The grievance raised by the petitioner against Annexure-5 for appointment on the post of Ayush Doctors, Pharmacist and ANMs is required to be dismissed because the examination has been conducted on the basis of a judicial order passed in CWJC No.22835 of 2013, decided on 16.5.2014, a copy of which is Annexure- A.

So long as that order is not held to be bad by a higher

forum, no interference would be warranted with the exercise so done and the appointments so made. It is too late in the day for the petitioners to raise a grievance against Annexure-5.

Writ has no merit. It is dismissed.
