Heard learned counsels for the parties.

The writ application, seeking a direction or a mandamus for regularizing the period of service of the petitioner as regular Headmistress from Incharge Headmistress, is not required to be re-adjudicated, because such an issue had already been raised in a batch of writ applications, which have been decided by a Learned Single Judge in C. W. J. C. No. 10874 of 2010 and other analogous cases, vide order, dated 22.05.2015. The relevant paragraph with regard to the issue raised by the petitioner is

reflected from paragraph 92 onwards.

The law laid down by the said Bench covers the case of the petitioner. No relief can be granted in favour of the petitioner.

Writ application is dismissed, accordingly.
