The present writ petition is directed against an order

passed by the Central Administrative Tribunal, Patna Bench, Patna (hereinafter referred to as the ‘Tribunal’) on 9th December, 2015 whereby, an Original Application filed by the respondents herein was allowed. The writ petition was directed to consider the case of the applicants for fixing the revised pay scale as per the 6th Central Pay Commission Report.
