Heard learned counsel for the parties.

3rd supplementary show cause has been filed on behalf of opposite party no. 3, who is personally present in Court. The same discloses that in terms of the order of the Court dated 16.01.2015 passed in C.W.J.C. No. 14687 of 2008, payments have been credited

to the account of the petitioner.

In view of the aforesaid, the present contempt petition, having become infructuous, stands disposed off.

Learned counsel for the petitioner submits that certain dues payable to the petitioner still remain.
