After some argument, the learned counsel appearing on behalf of the petitioner, in presence of the learned GP-11 appearing on behalf of the respondent nos.1 to 4, seeks permission to withdraw the present writ petition with a liberty to approach the prescribed appellate authority under the provisions of The Bihar Land Disputes Resolution Act, 2009 for grant of an appropriate relief to the petitioner with respect to the lands in question as also the impugned order dated 16.01.2013 passed in Land Dispute Case No.451 of 2012-13 by the respondent D.C.L.R., Darbhanga, as contained in Annexure-4.
