This is an application, made under Section 439 of the
Code of Criminal Procedure, seeking bail for the accused-
petitioner, namely, Anil @ Gorakh @ Anil Singh, in connection
with Dehri Nagar Police Station Case No. 490 of 2015, under
Sections 341/323/332/353/307/379/504/34 of the Indian Penal
Code and Section 27 of the Arms Act, 1959.

Perused the above application and materials on
record.

Heard Mr. Rajesh Kumar Singh, learned Counsel for
the petitioner, and Mr. Tarkeshwar Nath Thakur, learned
Additional Public Prosecutor, appearing on behalf of the State.

In view of the fact that the accused above-named was
arrested on 12.06.2016 on the basis of the confessional statement
of co-accused, namely, Satish Kumar Singh, who has been
granted bail by a Bench of this Court by the order, dated
14.01.2016, passed in Cr. Misc. No.1395 of 2016, coupled with

the fact that perusal of the materials available does not reveal such incriminating materials, which would warrant further detention of the accused-petitioner in custody, and in view also of the fact that the perusal of the materials does not reveal that the accused-petitioner's liberty on bail would adversely affect his trial, it is, in the interest of justice, hereby directed that the accused above-named shall be released on bail of Rs. 10,000/- with two sureties, each of the like amount, subject to the satisfaction of the learned Sub-Divisional Judicial Magistrate, Dehri, in connection with Dehri Town Police Station Case No. 490 of 2015.

This direction for bail is further subject to the condition that the accused above-named shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any police officer or tamper with the evidence and shall appear, in the learned Court below, as may be directed.

In terms of the above observations and directions, this bail application shall stand disposed of.
