withdraw the present writ petition with a liberty to approach the
Civil Court of competent jurisdiction for grant of appropriate
relief(s) to the petitioner with respect to the lands in question
claimed by him.

The writ petition stands dismissed as withdrawn with the liberty aforesaid.

It goes without saying that, if the claim of right, title and possession of the petitioner is accepted by the Civil Court of competent jurisdiction, after hearing all the parties including the private respondents herein, then he shall be at liberty to file a fresh petition for mutation of his name with respect to the lands in question before the prescribed authority.
