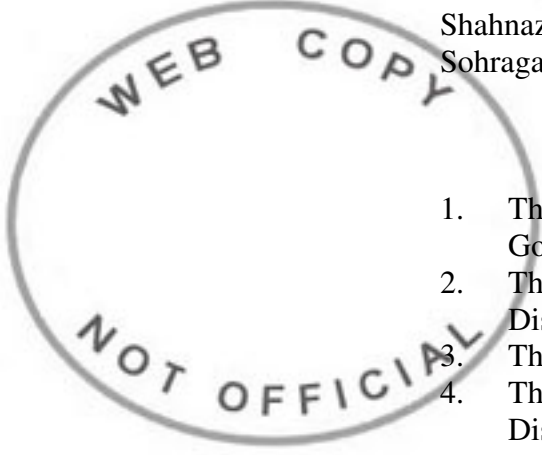

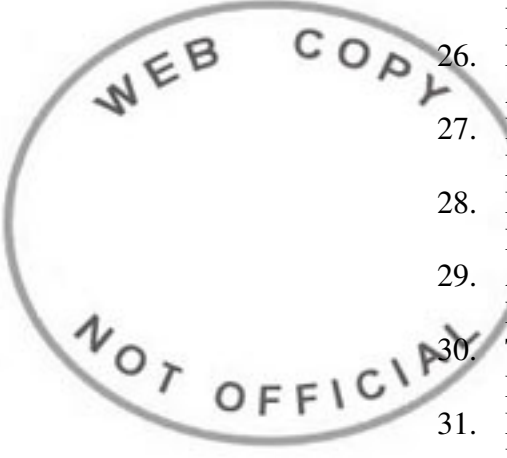

The

conduct of the petitioner itself reflects that she is not interested in pursuing her remedy inasmuch as once there is a re-election to elect a new Up-Pramukh and which is not put to question then the removal of the Up-Pramukh in the no confidence motion becomes academic and taking note of such circumstances the writ petition is disposed of accordingly.
