for the State.

In this case, the petitioner is seeking bail in connection with Buxar (T) P.S. Case No. 356 of 2015 for offence under Sections 147, 148, 149, 341, 302, 120(B) of the Indian Penal Code and Section 27 of the Arms Act.

An allegation has been made that ten persons and some other unknown persons have intercepted the brother of the Informant and resorted firing due to which the brother of the Informant died at the spot. The name of the petitioner has come in the confessional statement.

Learned counsel for the petitioner submits that most of the accused persons have been granted bail such as Ram

Pravesh Singh by order dated 9.12.2015 in Cr. Misc. No. 54759 of 2015, Chandan Singh and Sriman Narain by order dated 8.12.2015 in Cr. Misc. No. 54551 of 2015, Pradeep Keshri by order dated 11.12.2015 in Cr. Misc. No. 55144 of 2015, Raju Thakur by order dated 15.12.2015 in Cr. Misc. No. 56120 of 2015, Rajdeep Singh @ Rajdeep Kushwaha by order dated 17.12.2015 in Cr. Misc. No. 56953 of 2015 and Narendra Kumar Pathak @ Nagendra Kumar Pathak @ Narendra Kumar @ Nagendra Kumar @ Dablu Pathak by order dated 19.1.2016 in Cr. Misc. No. 53952 of 2015.

Looking to the entire facts and circumstances of the case, let the petitioner, namely, Sonu Yadav @ Barud Baba @ Barud be released on bail on furnishing bail bond of Rs. 10,000/- (Ten Thousand) with two sureties of the like amount each to the satisfaction of learned Chief Judicial Magistrate, Buxar in connection with Buxar (T) P.S. Case No. 356 of 2015.
