The said regulation has been approved by the State and notified by the Examination Board. They inform the Court that they will try to complete the process with regard to all such institutions, which will apply at the earliest, but preferably within a



period of two months.

Be that as it may, all these writ applications now stand disposed off in view of the above developments.
