Law being what it is and that report having been duly approved by the Hon'ble Supreme Court of India in *State of Bihar & Others vs. Bihar Rajya M.S.E.S.K.K. Mahasangh & Ors.*, AIR 2005 SC 1605, this Court is not willing and cannot add names and



subtract names over and above the report which has the seal of approval of the Hon’ble Apex Court. The exercise sought to be done by the petitioner before this Court, therefore, is misplaced.
