Since both the cases arise out of I.F. Case No.09 of

2016, they have been heard together and are being disposed of by

this common order.

Heard learned counsel for the petitioners as well as learned Additional Public Prosecutor for the State.

Petitioners seek bail in a case registered under Sections 9, 27, 39(B), 44, 49(B) WL Protection Act.

Some persons were caught with bones and skin of the tiger. The aforesaid persons disclosed the name of the petitioners and some others. Moreover, it is informed on behalf of the petitioners that several co-accused having more or less similar allegation have already been granted privilege of bail whereas petitioners are in jail custody since long.
