Through this writ application, the petitioner seeks direction to respondents for payment of post retiral dues as he has retired from service on 30.04.2015 from the post of Messenger (IVth Grade), Electric Supply Sub-Division, Makhdumpur, Jehanabad. Though a copy of the writ petition was served upon the respondents on 25.08.2015 itself, no counter affidavit has been filed as yet.

Accordingly, this writ application is disposed of with a

direction to The Managing Director, South Bihar Power Distribution Company Limited, Vidyut Bhawan, Bailey Road, Patna to consider the case of the petitioner to take a decision after due calculation of the admissible amount of post retrial dues payable to the petitioner along with statutory interest, if any, and make payment to the petitioner after such calculation of the admissible amount within a period of three months from the date of receipt/production of a copy of this order.

The Electrical Executive Engineer, Electric Supply Sub - Division, Makhdumpur, Jehanabad is required to immediately transmit the necessary requisite documents including the representation of the petitioner to The Managing Director, South Bihar Power Distribution Company Limited, Vidyut Bhawan, Bailey Road, Patna.
