Heard learned counsel for the petitioners.

Gone through the order impugned.

It has been contended on behalf of learned counsel for the petitioners that defendant third party happens to be party proforma on account thereof, the order sheet could not have been admitted as an exhibit on their behalf in the background of the fact that same was filed on behalf of plaintiffs and further, regarding which (Collectorate partition), there happens to be admission at the end of petitioners/ defendant first set under Para-8 of the written statement.

Document was filed on behalf of plaintiffs and, being admitted by the adversary can be marked as an exhibit. Whether the status of defendant third party be a party proforma is irrelevant for the aforesaid purpose.

Petition lacks merit and is accordingly, rejected.
