In view of the statement made in the affidavit filed today

on behalf of the opposite party nos. 3 to 5 stating categorically that the opposite party nos. 6 to 10 have not encroached the land.

In my view, this proceeding cannot proceed further.

Accordingly, this contempt proceeding is dropped.

The personal appearance of the Circle Officer, Dumra, Sitamarhi, is dispensed with.

However, if the petitioner is still aggrieved he will be at liberty to raise the issue before a competent authority.
