2 13-01-2016 The instant application has come up for modification of the order dated 21.09.2015 passed in Cr.Misc.No.24439 of 2015 to the effect that the period of surrender of the petitioners in the court below may be extended as well as for correction of Complaint Case number in the last paragraph of the said order.
