In view of the limited prayer made at the time of hearing, this writ application is being disposed of with a liberty to the petitioner to approach the District Magistrate, Samastipur to file a fresh representation setting out his grievance. On such representation having been filed, let him examine the issue regarding the



encroachment of any public land or Rasta as claimed by the petitioner on its own merit and in accordance with law expeditiously preferably within a period of four months from the date of receipt/production of a copy of this order, as counter affidavit does not disclose that order was passed by the Circle Officer holing that there is no encroachment on any public land. It is merely being stated in the counter affidavit that map does not show public Rasta.
