It is stated by learned counsel for the petitioners

in the two cases that all of them have been granted anticipatory
bail by the common order dated 5.11.2015 but on account of the
illness of one of the original petitioners, Savitri Devi and further

her death on 13.12.2015, they could not surrender for the purpose of bail.

In the above circumstances, it is directed that date of surrender in the order dated 5.11.2015 shall be extended to a period of four weeks from today with regard to the three petitioners.

The order dated 5.11.2015 passed in Cr. Misc. Nos. 44549/2015 and 45938/2015 is modified to the above extent with respect to the three present petitioners only.
