Considered the show-cause filed on behalf of the opposite parties. Since there have been various kinds of direction issued from time to time by different Benches in relation to preparation of panel in the district for appointment on Class IV post, naturally some kind of



reconciliation and harmony has to be worked out and this is what has been done by the Committee, which met and tested the issue on 29.11.2016. A copy of the Committee's minutes and decision is Annexure-B to the show-cause.

2. It is hoped and expected that the opposite parties would now take a final decision depending upon the people who make the cut and those who do not. Matter should not be unduly delayed now unless some more judicial orders have been passed thereafter which does not seem probable.

3. Contempt application is disposed of in terms of the above.
