counsel for the petitioner that during pendency of the application,

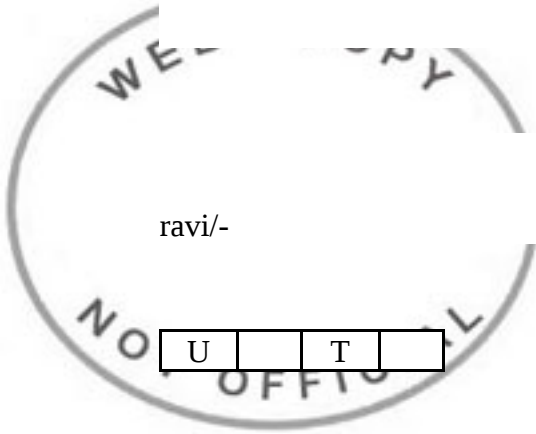
the petitioner has already been acquitted by the trial Court.
