Order On Board**10/08/2016**

1. Learned counsel for the petitioners seeks permission of the Court to withdraw the Writ Petitions with liberty to prefer an appeal before the CIT (Appeals). He would also pray that the appeal to be preferred before the CIT (Appeals) may be directed to be disposed of within 4 weeks as has been directed in some other similar petitions. He would submit that the petitioners are willing to move application for grant of interim relief before the appellate authority and the same may be considered within a week of filing the appeal.
2. In view of the submissions made, the Writ Petitions are dismissed as withdrawn with liberty to the petitioners to prefer an appeal before the CIT (Appeals) along with application for grant of interim relief. The appellate authority shall pass orders on prayer for grant of interim relief within a week and thereafter decide the appeal itself within a period of 4 weeks.
