AWARD

(Passed on 12th November, 2016)

The contesting parties of this appeal have amicably settled/compromised the dispute, which is subject matter of this appeal, voluntarily. We have also found that the terms and conditions of compromise/settlement arrived at between the contesting parties are just, proper and legal and hence are acceptable. We accordingly accept the compromise/settlement, proposed by the parties and order that in addition to the amount of compensation awarded by

the Tribunal, the respondent No.4, Bajaj Allianz General Insurance Company Ltd., shall pay to the appellant a sum of **Rs.50,000/- (Rupees Fifty Thousand only)** by way of compensation, **within forty five days** from today, otherwise, interest @ 6% per annum from the date of present award, shall also be payable till its realization.
