PER COURT :

1. Mr.Talekar, learned counsel appearing for petitioner in Writ Petition St.No.11123/2015, has filed Civil Application seeking leave to amend and to add documents. He also seeks oral leave to add parties i.e. the other petitioners in W.P.No.3393/2016 and W.P.No.3787/2016.
