ORDER :

1. Notice in delay condonation applications. The learned AGP waives notice for respondent/State and Land Acquisition Officer. Learned counsel Shri. Bhosle h/f. Mr. A.B. In view of the contents of the applications and submissions made and difficulties faced by the Department of Government in processing the matter and collecting funds, this Court holds that sufficient cause is shown.
