ORDER:

1) Notice on civil applications filed for grant of leave and on civil applications filed for condonation of delay. Learned Assistant Government Pleader waives notice for State of Maharashtra. Notice to other respondents made returnable on 8th June 2016. Call record and proceeding.

2) Heard learned counsel for the acquiring body on civil applications filed for stay. Seen the judgment and award. This Court holds that stay needs to be granted subject to condition of deposit of the entire amount of compensation within 12 weeks from today. If the amount is not deposited within the fixed time, it is to be presumed that there is no stay to the execution of the judgment and award of the Reference Court.
