PER COURT :

The learned Assistant Government Pleader for respondent nos.1 and 2, on instructions, states that a Public Interest Litigation bearing No. 20 of 2006 (with Civil Application No. 137 of 2009) is filed at Principal Seat at Bombay, wherein interim orders are passed of not giving financial assistance to the private Sugar Factories.
4. Considering the above and the fact that the Counsel for the petitioners is consistently absent, the Writ Petition is dismissed. Rule is discharged. No costs.
