Learned Counsel further submitted that, however, since the acquiring body could not deposit the amount within the given period, the stay so granted was vacated, however, liberty was granted to the acquiring body to revive the request for stay provided the request is accompanied with an assurance to deposit the amount. Learned Counsel submits that, the applications be allowed. Hence, following order.

ORDER

1. The applications are allowed. The appellant / applicant is permitted to deposit the amount of compensation with the Registry of this Court within one week from the date of this order. In view of the fact that the amount is being deposited as above, the execution of the impugned awards are stayed till final disposal of the present appeals. Civil Applications stand disposed of.
