1. This Appeal relates to Assessment for Block Period 1st April 1988 to 28th April 1998. Mr Suresh Kumar, learned counsel for the Revenue states that the tax effect in the present Appeal as indicated in para 10 of the Appeal Memos is Rs.14.29 lakhs.
