1. The convening and holding the meeting of the Equity Shareholders of the Applicant Company for the purpose of considering and, if thought fit, approving, with or without modification(s) the proposed Scheme of Amalgamation of Mahasen Developers & Farms Private Limited, Shri Bhairav Properties & Agrofarms Private Limited, Siddheshwer Real Estate Private Limited, Balaji Hi-Tech Reality And Engineers Private Limited And Aashi Realities Private Limited with Arhanathji Builders And Farms Private Limited and their
