1. On 3<sup>rd</sup> February, 2016 this Court passed the following order :

*“1.Perused the order dated 29-01-2016. Mr. Firdosh Pooniwala, Advocate, has in his disclosure stated that in the past, he has been briefed as a Counsel by M/s. Thakore Jariwala and Associates, Advocates for the Respondents in the captioned matters. In view thereof, by consent of the parties, the disputes in the above Arbitration Applications are proposed to be referred to Mr. Minoo Siodia, Advocate. In view thereof, Mr. Minoo Siodia, Advocate, shall submit his disclosure under Section 11(8) read with Section 12(1) of Arbitration and Conciliation Act, 1996.*

2. Pursuant to the above order, Mr.Minoo Siodia, Advocate & Solicitor has filed disclosure under Section 11(8) read with Section 12(1) of the Arbitration and Conciliation Act, 1996. The same is taken on record and the following order is passed by consent :

- i. The disputes arising out of the Joint Venture Agreement dated 12<sup>th</sup> February, 2011, Services Agreement dated 2<sup>nd</sup> August, 2012, Agreement dated 2<sup>nd</sup> May, 2011 and Settlement Agreement dated 19<sup>th</sup> January, 2013 between the parties are referred to the sole Arbitration of Mr.Minoo Siodia, Advocate & Solicitor.
  - ii. The parties shall appear before the learned Arbitrator in his chambers, on 17<sup>th</sup> February, 2016 at 5.00 p.m. and obtain necessary directions.
  - iii. The cost of arbitration shall initially be borne by the parties equally.
  - iv. All contentions of the parties are kept open.
  - v. The venue of Arbitration shall be at Mumbai.
3. In view of this order, the above Arbitration Applications are disposed of.
