1. A reasoned order was passed by this Court dated 2nd December, 2016,
operative portion of which is reproduced hereunder :

- “i. The Court proposes to appoint Mr. Vishal Talsania, Advocate to decide the disputes of the Applicant and the Respondent arising out of the Agreement dated 12th September, 2013 (Exhibit B to the Application). In view thereof, Mr. Vishal Talsania, Advocate shall submit disclosure under Section 11 (8) read with Section 12 (1) of Arbitration and Conciliation Act, 1996.*
- ii. The Advocate for the Applicant shall forward a copy of this order to Mr. Vishal Talsania, Advocate as well as to the Respondent by Speed Post A.D, at its last known address.*
- iii. All concerned to act on an ordinary copy of this order duly authenticated by the learned Associate of this Court.*
- iv. Stand over to 16th December, 2016.”*

2. The learned Advocate for the Applicant tendered Affidavit of Service dated 16th December, 2016. Accordingly, Mr. Vishal Talsania, Advocate, has filed his disclosure under Section 11 (8) read with Section 12 (1) of the Arbitration and Conciliation Act, 1996, which is taken on record and the following order is passed :

(i) Mr. Vishal Talsania, Advocate, is appointed as a Sole Arbitrator to decide the disputes of the Applicant and the Respondent arising out of the Agreement dated 12th September, 2013 (Exhibit B to the Application).

(iii) The parties and their Advocates shall appear before the learned Arbitrator in his chambers, on 9th January, 2017 at 05.30 p.m. and obtain necessary directions.

(iii) The learned Arbitrator shall endeavour to pass his final Award within a period of six months from the date of this order.

(iv) All contentions of the parties are kept open.

(v) The cost of arbitration shall initially be borne by the parties equally.

(vi) The venue of Arbitration shall be at Mumbai.

(vi) In view of this order, the above Arbitration Application is disposed of.

(vii) A copy of this order shall be forthwith forwarded to the Respondent by the Advocate for the Applicant by Speed Post A.D.
