1. The convening and holding the meeting of all the Equity Shareholders of the Applicant Company for the purpose of considering and, if thought fit, approving with or without modification(s), the proposed Scheme of Amalgamation of Pivotal Securities Private Limited and Gazebo Estates Private Limited and Sunidhi Wealth Advisors Private Limited and Imperial Corporate Finance and Services Private Limited and R K Chari Stock Broking Private Limited with Jasvantlal Chhotalal and Company Private Limited and their respective shareholders is dispensed with in view of the consent given by both the Equity Shareholders of the Applicant Company, which are annexed as Exhibits “C1 – C2” to the affidavit in support of the Company Summons for Direction.

The convening and holding the meeting of Unsecured Creditors of the Applicant Company, for the purpose of considering and, if thought fit, approving with or without modification(s) the proposed Scheme of Amalgamation of Pivotal Securities Private Limited and Gazebo Estates Private Limited and Sunidhi Wealth Advisors Private Limited and Imperial Corporate Finance and Services Private Limited and R K Chari Stock Broking Private Limited with Jasvantlal Chhotalal and Company Private Limited and their respective shareholders is dispensed with in view of averments made in paragraph 14 of Affidavit in support of Summons for Directions, inter-alia stating that present Scheme of Amalgamation is an arrangement between the Applicant Company and its Shareholders as contemplated under Section 391(1)(b) and not in accordance with the provisions of Section 391(1)(a) of the Companies Act, 1956 as there is no compromise and/or arrangement with the creditors as no sacrifice is called for and in terms of the proposed Scheme, the Transferee Company will take over all the assets and liabilities of the Applicant Company. The Applicant Company undertakes to issue notice of hearing of Company Scheme Petition to all of its Unsecured creditors by R.P.A.D and publish common and composite notices of the date of hearing of petition in English in 'Free Press Journal' in English

language and translation thereof in 'Navshakti' in Marathi Language. The said undertaking is accepted.
