The convening and holding the meeting of the Equity Shareholders of the Applicant Company, for the purpose of considering and, if thought fit, approving, with or without modification(s), the proposed Scheme of Amalgamation of Kare Edumin Private Limited with Eduspark International Private Limited and their respective shareholders and creditors, is dispensed with, in view of the consents given by both the Equity Shareholders of the Applicant Company, which are annexed as Exhibits “G1” & “G2” to the Affidavit in support of the Company Summons for Direction.

The said undertaking is accepted.
