The convening and holding the meeting of the Equity Shareholders of the Applicant Company for the purpose of considering and, if thought fit, approving, with or without modification(s), the proposed Scheme of Amalgamation of Beauty Glass Private Limited with Vijay Vision Private Limited, is dispensed with in view of the consents given by all the four (4) Equity Shareholders of the Applicant Company, which are annexed as **EXHIBITS “K-1” to “K-4”** to the Affidavit in support of the Summons for Directions.
