petitioner to workout his remedies in the manner known to law.

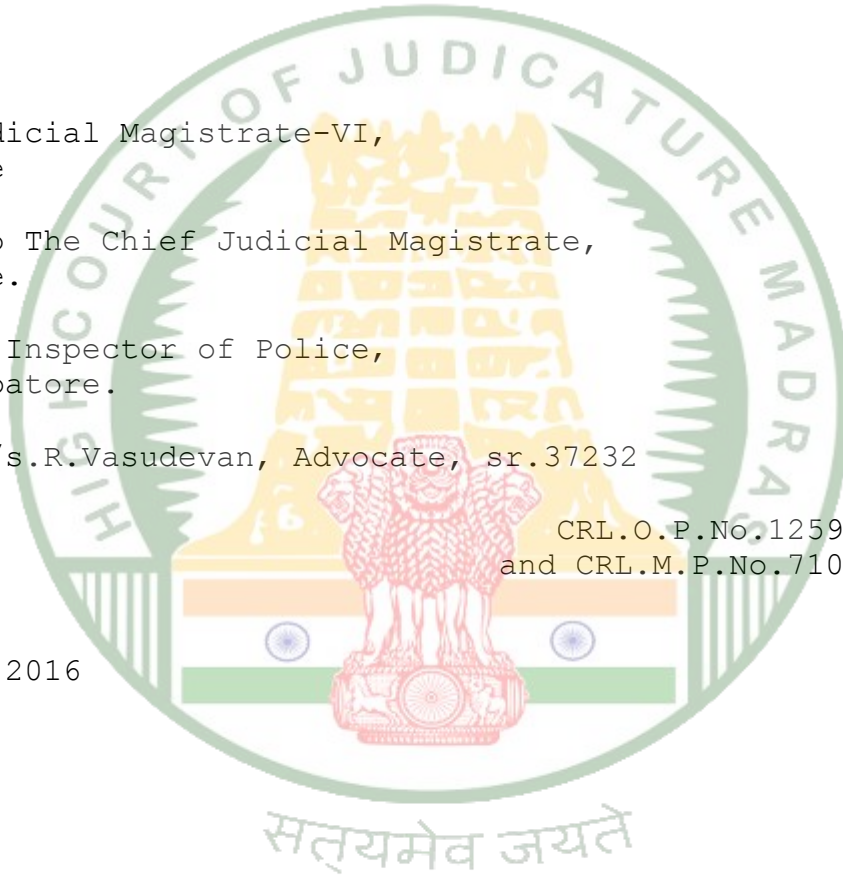
